High Volume Oxygen provides a warranty on its products (the "Products") against defects in material and workmanship, under normal use and operation, to the extent set forth in this warranty. The warranty of the manufacturer covers brand new products only, extends only to the original customer and is not transferable. It pertains only to products that have not been modified altered or repaired.

THIS WARRANTY IS THE SOLE AND EXCLUSIVE WARRANTY OF HIGH VOLUME OXYGEN WITH RESPECT TO THE PRODUCTS AND IS IN LIEU OF ALL OTHER WARRANTIES EXPRESSED OR IMPLIED ALL OF WHICH ARE HEREBY DISCLAIMED TO THE FULLEST EXTENT PERMITTED BY APPLICABLE LAW. WITHOUT LIMITING THE GENERALITY OF THE FOREGOING DISCLAIMER AND EXCEPT AS OTHERWISE SET FORTH IN THIS WARRANTY, HIGH VOLUME OXYGEN DISCLAIMS ALL WARRANTIES OF MERCHANTABILITY WITH RESPECT TO THE PRODUCTS AND ALL WARRANTIES OF FITNESS FOR A PARTICULAR PURPOSE.

The HIGH VOLUME OXYGEN Warranty provides the following:

- 1) HIGH VOLUME OXYGEN shall repair or replace the Products free of charge to the original user where defects in the material and/or workmanship are evident at the time of delivery. Such replacement of the Products does not include damages incurred in shipping the Products. If shipping damage is evident, the original user should contact the shipper immediately. HIGH VOLUME OXYGEN will pay for shipping the Products to the original user as well as returning damaged/defective Products to HIGH VOLUME OXYGEN. Once the Products are repaired, HIGH VOLUME OXYGEN will ship the Products back to the original user and cover all costs incurred in shipping.
- 2) HIGH VOLUME OXYGEN shall repair or replace the Products free of charge to the original user where defects in material and/or workmanship become evident between the date of delivery to the original user and three (3) years from the date of delivery to the original user. HIGH VOLUME OXYGEN will pay for shipping the products to the original user as well as returning damaged/defective Products to HIGH VOLUME OXYGEN. Once the Products are repaired, HIGH VOLUME OXYGEN will ship the Products back to the original user and cover all costs incurred in shipping. HIGH VOLUME OXYGEN bears no responsibility or liability for the cost of labor for the removal of component parts or equipment that constitute part of the Products, packaging of the component parts or equipment that constitute part of the Products or the re-installation or replacement of the component parts or equipment that constitute part of the Products. NOTE -- Failure to return damaged/defective Products will void the warranty.
- 3) The warranty provided by HIGH VOLUME OXYGEN to the original user covers parts and equipment specifically manufactured by HIGH VOLUME OXYGEN and used as components or equipment that constitute part of the HV machine as well as third party parts and equipment ( i.e. gauges, relays, compressors) that constitute part of the mechanical operation of the HV machine itself. HIGH VOLUME OXYGEN is not in any way responsible for third party PSA equipment (oxygen generators) used in conjunction with the HV system.

Return Authorization must be obtained from HIGH VOLUME OXYGEN prior to the return.

Note: The warranties of HIGH VOLUME OXYGEN as set forth herein shall also become null, void and not binding on HIGH VOLUME OXYGEN if a defect or malfunction occurs in the Products or any part of the Products as a result of:

- a) Running the HV machine without adequate electrical power or with extension cords. (See manual.)
- b) Running the HV machine with closed lines or inadequate inflow. (See manual for minimum oxygen input.)
- c) Any unauthorized adjustments to the digital controller.
- d) Any adjustments and or tampering with internal equipment such as steel lines, electrical, etc.
- e) Failure to provide the Required Operating Conditions for the Products, i.e. outdoor operation, or extreme indoor conditions such as dusty, dirty or greasy conditions, or extreme heat, humidity or cold.
- f) Repair, attempted repair, adjustment or servicing of the Products, or any component parts or equipment that constitutes part of the Products by anyone other than an authorized representative of HIGH VOLUME OXYGEN. The authorized service representative must obtain prior approval from HIGH VOLUME OXYGEN before performing any warranty work.
- g) External Causes (e.g. any natural disaster, or any event deemed an "Act of God" such as flood or hurricane).

HIGH VOLUME OXYGEN is not liable for any special, indirect, punitive, economic, incidental or consequential losses or damages including without limitation, loss of use, malfunction of HIGH VOLUME OXYGEN products, replacement oxygen charges, delays or lost savings related to the Products or otherwise even if HIGH VOLUME OXYGEN shall have been advised of the possibility of such potential losses or damages. HIGH VOLUME OXYGEN Oxygen Generator products shall not be used for human breathable or human medical oxygen Applications.
